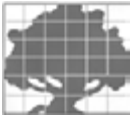

INTRODUCTION

The criterion for membership in the Giannini Foundation of Agricultural Economics has varied widely since its establishment. The founding members appointed by Director Claude B. Hutchison drew a cadre of thirteen academics and specialists from the university's Division of Rural Institutions. Some were agricultural economists. Others were from fields with strong ties to the early development of California's agriculture. Founding members were accorded membership status in several titles:

Variations in membership titles have evolved over time, compounded by decentralization of the universitywide College of Agriculture from Berkeley to include colleges and additional academic programs at Los Angeles, Davis, and Riverside. Cooperative Extension specialists in agricultural economics are now assigned to academic departments at Berkeley and Davis.

Over the three-quarter-century history of the Foundation, one observes many inconsistencies in the titles given for both academics and specialists. Full memberships generally have been conferred on all professorial appointees in agricultural economics (save for a few exceptions noted in the early history for nontenured assistant professors who were accorded full membership only with advancement to tenure). Members of a small unit of natural resource and environmental economists on the Riverside campus also have historically been regarded as members.



Cooperative Extension specialists have historically been identified as associate members but distinctions in the programmatic contributions of academic and specialist programs are blurring. Several recent academic appointments include both academic and Cooperative Extension responsibilities. Variations also included associate memberships for USDA's Economic Research Service field staff beginning after World War II and continuing through the early 1980s, when all field staff positions were withdrawn from land grant universities.

And, from time to time, associate status has been assigned to others. A recent use of the associate title is for adjunct professors and nondepartmental academics with interest in and contributions to the academic departments and the Foundation. Associate memberships can be conferred by nomination and approval of the executive committee. Recent associate memberships include adjunct professors at Berkeley and Davis and economic historians associated with the Agricultural History Center at Davis. None of these are included by name in the tables that follow because of inconsistent, often honorific, use and apparent lack of official documentation in the assignment of associate memberships.

Both professorial agricultural economists (academics) and Cooperative Extension agricultural economists (specialists) are regarded as members in the compilations that follow. Forest economists also continue to be identified with Giannini activities and are identified as associates.

Member status is consistently identified in the tables as (1) academic (all professorial appointees), (2) specialist (all Cooperative Extension appointees), or (3) associate (forest economists). We choose not to explain variations that appear in historical records. We include all universitywide appointments in agricultural economics, initially at Berkeley and then followed by campus programs at Los Angeles (first campus appointment in 1939; program terminated in 1959), Davis (first campus appointment in 1947), and Riverside (first campus academic appointment in 1959).
